B. SUNSHINE LAW

F. FINANCE

1. Changes Orders

It is recommended the Board of Education approve the following change orders for the Interior Renovations Projects:

PCO No. 1 for keeping the classroom grids and only replacing ceiling tiles- (\$12,985.31)

PCO No. 2A for Wiring and Cabling- \$14,426.42

PCO No. 3 for insulation replacement- \$74,612.23

PCO No 5 for relocating exit signs and smoke detectors- \$2,324.54

G. TRANSPORTATION

1. Sheppard Bus Training Program

It is recommended the Board of Education approve allocating \$20,000 of ESSER II Funds to pay for School Bus Driver Training for prospective drivers to work for the Commercial Township School. The cost per training is \$4,850 and employees who leave during the first year would reimburse the district 100% of the training, and 50% if they leave during year 2.
