- 1. Resolution to Submit Bond Referendum Question By resolution, the Bond Referendum Question to be submitted to the County Clerk's Office for the March 8, 2022 Special Election as follows:
  - The Board of Education of the Township of Commercial in the County of Cumberland, New Jersey is authorized (a) to undertake various renovations, alterations, improvements and upgrades at Commercial Township Elementary School, including acquisition and installation of fixtures, equipment, and any related site work; and (b) to appropriate \$3,060,423, and to issue bonds in an amount not to exceed \$3,060,423.

The State debt service aid percentage will equal 68.7314% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this special election.
